Player Contract and Waiver of Liability

**TERMS OF ALL AMERICAN LEAGUE – PATRIOT DIVISION APPLICATION AND PARTICIPATION**

1. This agreement represents the complete understanding between the APPLICANT and the All American League – Patriot Division (Hereafter referred to as AALPD) as well as the governing body of the AALPD, MVP4Life. No representations, written or oral, other than those contained within this agreement are authorized by or binding upon AALPD or MVP4Life.
2. Management of AALPD or The Strike Zone may suspend or cancel the rights, privileges, or membership of any applicant whose actions are detrimental to the enjoyment of The Strike Zone facilities or The AALPD by other members and applicants.
3. MVP4Life or The Strike Zone may, from time to time, change the rules or regulations governing the operations of MVP4Life and the AALPD. Notice of these changes will be made available to members through normal means of communications.
4. The Applicant will be liable for payment of all costs incurred by MVP4Life in the collection of past due payments to MVP4Life.
5. The Applicant acknowledges and accepts the risks inherent in the use of The Strike services, facilities, and participation in the AALPD. By use of The Strike Zone facilities, services and Upper Deck League Participation, the applicant hereby voluntarily assumes the risk of injury, accident, death, loss, cost, or damage to his or her personal property which might arise from the use of MVP4LIFE services, The Strike Zone facilities, or/and AALPD Participation. The Applicant, his or her heirs, executors, representatives or assigns, hereby release MVP4Life and the Strike Zone from all claims or liabilities for personal injury or property damage of any kind, sustained by the applicant while on the premises of MVP4Life/The Strike Zone or off campus sites at which games or practices are being executed except for injuries or damage directly caused by the willful misconduct of the officers, employees, or agents of MVP4Life.
6. The purpose of this agreement is to insure that the Applicant understands the duties and responsibilities of AALPD participation. This is a legally binding agreement and if it is not understood by the Applicant, he or she could consult an attorney of his or her choice.

It is the responsibility of the APPLICANT to ensure that MVP4Life has proper information needed for participation.
